Approval of biogas plant

1. In accordance with Regulation 14 of The Animal By-Products (Enforcement) (England) Regulations 2013/The Animal By-Products (Enforcement) (Wales) Regulations 2014, and Articles 24 and 44 of Regulation (EC) No. 1069/2009, the Secretary of State/Welsh Ministers approves:

to operate a biogas plant on the premises to treat Category 3 animal by-products, including catering waste/permitted Category 2 materials in accordance with the Annex.

2. Samples of the treated product shall be taken after processing in the pasteurization tanks (*Escherichia coli* immediately after the size/ time/temperature parameters have been achieved; and *Salmonella* during or on withdrawal from storage, after the size/time/temperature parameters have been achieved), at the minimum frequency of one sample per calendar month, and tested for *Salmonella* and *E.coli* (or *Enterococaceae*).

## Annex

1. The animal by-products/catering waste must be reduced in size to a particle size of no more than 12mm using one of the 3 dominator screens (dominators 1 and 2 with 11mm size holes perforated drum and dominator 3 with 8mm size holes perforated drum) or the Simplex Basket Strainer and Filter (with 12mm size holes perforated basket) and treated in one of the 3 pasteurization units in such a way that the animal by-products/catering waste achieve at least 70oC during a minimum time of 60 minutes before moving into the digestion tank.

## Notes

1. Processed (rendered) material derived from Category 1 material may not be treated in a composting or biogas plant. If other processed material is treated in a composting or biogas plant, it must have been produced by:
  - (a) processing Category 2 animal by-products by method 1 in an approved processing plant;
  - (b) processing Category 3 animal by-products by one of methods 1-7 in an approved processing plant.
2. The following Category 2 materials can be used in compost and biogas plants without prior method 1 processing:
  - L manure
  - L digestive tract and its content
  - L milk
  - L milk based products
  - L colostrum
  - L eggs and egg products which the competent authority does not consider to present a risk for the spread of any serious transmissible disease.
3. The following Category 2 materials can be used in compost and biogas plants without the need for pasteurisation:
  - L manure
  - L digestive tract content separated from the digestive tract
  - L milk
  - L milk based products and
  - L colostrum which the competent authority does not consider to present a risk for the spread of any serious transmissible disease.
4. All the conditions of The Animal By-Products (Enforcement) (England) Regulations 2013/The Animal By-Products (Enforcement) (Wales) Regulations 2014 and Regulation (EC) No. 1069/2009 and Regulation (EU) No. 142/2011 must be complied with.
5. In the event of an unsatisfactory bacteriological result, Animal and Plant Health Agency (APHA) must be informed immediately and the procedure in the HACCP plan followed.
6. Changes to the ownership, address or operation of an approved animal by-product premises must be notified to your local APHA office.
